



FREQUENTLY ASK QUESTION (FAQ)

PROGRAM PENAJAAN PENGAJIAN TERTIARI 2020 TERTIARY EDUCATION SPONSORSHIP PROGRAMME (TESP 2020)

1. What is the tertiary education Program (TESP 2020)?

The tertiary education programme is a form of convertible loans under the Majlis Amanah Rakyat (MARA) for STPM leavers 2019, Matriculation/foundation/Diploma and equivalent for the first degree of education in the selected field and institution of higher Education (IPT) for the year 2020 entry session. Students who are pursuing their studies at the first degree level may also apply.

2. What are the eligibility requirements set by MARA?

Term and requirements of this Program can be referenced in the application guidelines placed in the MARA Portal.

3. Where can I check the list of the selected fields and the institution of higher education set by MARA ?

Kindly refer to the application guidelines placed in the MARA Portal.

4. I'm following a Diploma level study, am I eligible to apply?

Not allowed. This Program is opened to students who are attending the first degree study level only.

5. I am in the second year and currently pursuing my bachelor's degree in local IPT, am I eligible to apply?

You are eligible to apply for this TESP Program if your tertiary institution is in the list of IPT selected by MARA.

6. Does the TESP 2020 Program are the scholarships offered by MARA?

This is convertible loan. Students are encouraged to apply for a reduction of repayment after graduation. In addition, these loans are not subject to any interest rates.

7. How do I apply for the TESP 2020 Program?

An application can be made online via the official website of MARA <http://www.mara.gov.my> when the application is opened. The applicant must first register before filling in the application. Applicants are also advised to read and understand the guidelines provided prior to making the application.

8. When will the application of TESP 2020 be opened?

The application is open for 5 days from 6th July 2020 (Wednesday) at 10.00 am to 10th July 2019 (Monday) Hours by 4.00 pm.

9. Can I apply for the TESP 2020 Program if my parent has been blacklisted MARA?

Not Allowed. Mothers, fathers, guardians, guarantors and applicants need to be free from MARA blacklist. Applicants are advised to check the blacklist status in the MARA Credit Control division before applying for the TESP 2020 programme.

10. I got CGPA 3.0 at the foundations level in 2018. Can I apply?

Not allowed. The application is only opened to the students ' level and the completion of the study at 2019 only.

11. Do I need to send any documents after making an online application?

No need. Applicants only need to complete and complete the application by online (online). Don't submit any documents to us after we ask the applicant to do so.

12. When can I check the results?

The applicant is advised to always check in each email from time to time to find out any updates.
